### RELEASE AND WAIVER OF LIABILITY AND ASSUMPTION OF RISK

As a condition of use, I understand that the use of this park and recreational facilities means that I am taking and assuming certain risks of damage or injury to myself, my guest(s), my property, my dog (s) and to others in the park and associated facilities. I realize that when dogs are around people and other dogs, some accident or injury may result, and that people, dogs and property might be injured or damaged.

I hereby agree to assume these risks, for myself, my guests, my property, and my dog(s). I agree that it is solely my responsibility to determine whether the dog park property itself and any particular situation involving other members, guests and dogs is safe for myself, my guest(s), my property, and my dog(s).

In exchange for the opportunity to use this park and its facilities, according to the Rules and Regulations, I hereby release and discharge the Birmingham Jefferson Civic Center Authority, the Alabama Department of Transportation, and City Walk BHAM and its officers, directors, and employees from any and all liability, claims, demands, causes of action, loss, damage or injury to person or property, including any death, serious or other damage or injury which may result while I or my guest(s), my property, or my dog(s) are on the dog park premises.

I will hold harmless and indemnify the Birmingham Jefferson Civic Center Authority, the Alabama Department of Transportation, and City Walk BHAM, and its officers, directors from any and all liability, claims, demands, causes of action, loss, damage or injury to person or property, including any death and serious or other damage or injury which may be caused by myself, my guest(s), my property or my dog(s) while on the dog park premises.

I am 18 years old or older and have the legal capacity to enter into a binding agreement. I intend for this release to be binding upon my heirs, successors, beneficiaries, next of kin, personal representatives or executors, and assigns.

## THE BARKERY AT CITY WALK RULES AND REGULATIONS

*The Barkery @ City Walk BHAM is a membership-only off-leash dog park. The membership agreement and rules for membership are required to help us make sure our entire canine community is safe while enjoying The Barkery @ City Walk BHAM. As a condition of use, persons who choose to use the Dog Park agree to the following rules:*

**Please initial each rule** to indicate that you have read it, understand it, and agree to abide by it. **Health records including proof of spay/neuter must be provided.**

1. \_\_\_\_\_ The Daily Pass/Membership Agreement and Release of Liability release City Walk BHAM from any liability to you, your dog(s), or anybody accompanying you, and applies to all visits to City Walk BHAM and all City Walk BHAM facilities, including use of The Barkery at City Walk BHAM Dog Park and self-service wash stations, for the duration of your Membership. All dogs must have a one-time pass or a The Barkery at City Walk BHAM membership to be allowed into The Barkery at City Walk BHAM.
2. \_\_\_\_\_ Dogs must be spayed or neutered.
3. \_\_\_\_\_ Dogs must be current (up to date) on vaccinations including Rabies, DHPP/DHLPPC, and Bordetella. Dog parents must provide documentation to The Barkery at City Walk BHAM in order to be granted a one-time pass or The Barkery at City Walk BHAM membership.
4. \_\_\_\_\_ Puppies must be older than 6 months of age and must show that they are current on puppy vaccinations.
5. \_\_\_\_\_ No children under the age of 16 are allowed in the off-leash areas. NO EXCEPTIONS!
6. \_\_\_\_\_ Children must be supervised outside the off-leash areas at all times. Playing is at your own risk!
7. \_\_\_\_\_ Maximum of 2 dogs per member unless special permission is granted at management's discretion.
8. \_\_\_\_\_ Each member is responsible for cleaning up their dog's waste. Waste stations are stocked with plastic bags and available for your use. Ruff Rangers will monitor and assist when and as needed. However, outside of City Walk Dog Park, dog owners must immediately bag and dispose of any dog waste.
9. \_\_\_\_\_ Member understands and agrees that in bringing their dog(s) to City Walk BHAM, CITY WALK BHAM management and staff have relied on the member's representations and warranties that their dog is in good health and has not harmed or shown aggressive or threatening behavior toward any person or any other dog.
10. \_\_\_\_\_ Aggressive behavior will not be tolerated. Member is solely responsible for the behavior of their dog(s) and must break up any disturbances or any fights involving their dog(s). Any dog displaying disruptive or aggressive behavior may be asked to leave or required to be on-leash per CITY WALK BHAM management and staff's discretion.
11. \_\_\_\_\_ Only small (under 25 lbs.) or special needs dogs are allowed to use the small dog park. For safety reasons, it is strongly advised that dogs weighing less than 15 lbs. remain in the small dog park. No dogs weighing more than 25lbs. are allowed to enter the small dog park.
12. \_\_\_\_\_ City Walk BHAM is not responsible for any injury, illness, or damage caused on our premises, and all members are legally and financially responsible for their dog(s).
13. \_\_\_\_\_ Constant dog barking can be disruptive. Please keep your dog's barking under control.
14. \_\_\_\_\_ Please open only one gate at a time, and be careful not to allow other dogs to enter or exit with you.
15. \_\_\_\_\_ Member agrees to keep their dog(s) leashed when not inside designated off-leash areas (such off-leash areas, the "CITY WALK BHAM Dog Park"). Member may release their dog(s) from leash inside Barkery at City Walk BHAM Dog Park but must remain on the premises of City Walk BHAM while their dog(s) is (are) at the Barkery at City Walk BHAM Dog Park. Abandoning dogs is prohibited and is punishable by law. Violators are subject to revocation of their membership, may be permanently banned from using the Barkery at City Walk BHAM Dog Park, and reported to the City of Birmingham, as appropriate.
16. \_\_\_\_\_ No food – for humans or dogs – permitted inside the Barkery at City Walk BHAM. No dog treats or rawhide chews are allowed within fenced area.
17. \_\_\_\_\_ No glass bottles or containers are permitted on the premises.
18. \_\_\_\_\_ The Barkery at City Walk BHAM Dog Park closes due to severe weather (rain or snow) or when emergency maintenance is required. Additionally, the Barkery at City Walk BHAM Dog Park hours may vary due to special events. In all cases, Barkery at City Walk BHAM reserves the right to close the facility or amend its hours of operation at any time without notice; however, Barkery at City Walk BHAM will endeavor to

notify its members via our website, social media, and/or email.

19. \_\_\_\_\_ City Walk BHAM Management and Staff have the right to refuse service to any customer for any reason.
20. \_\_\_\_\_ Participation at The Barkery at City Walk BHAM is voluntary and at your own risk. We reserve the right to temporarily remove or permanently restrict any person or dog(s) from the premises for behavior that is potentially harmful to our patrons, staff, or other dogs. It is your sole responsibility to ensure the safety of your dog(s), your guests, and yourself. Your Membership may be suspended or revoked at any time if it is found that you have jeopardized the safety of other people or dogs at The Barkery at City Walk BHAM.
21. \_\_\_\_\_ No choke or prong collars are allowed in the off-leash areas.
22. \_\_\_\_\_ No dog toys except balls or frisbees are allowed.
23. \_\_\_\_\_ No bicycles, rollerblades, skateboards, strollers or scooters are allowed. No jogging allowed.
24. \_\_\_\_\_ The Barkery at City Walk BHAM is non-smoking, both inside and outside the off-leash areas. No tobacco products including vaping, illegal drugs or firearms are allowed in the park.

**I have read, understand, and agree to abide by all of the Dog Park Rules and Regulations, the Release and Waiver Liability and Assumption of Risk. I understand that City Walk BHAM reserves the right to alter or amend these rules and regulations at any time and that failure to follow them may result in the revocation of my permit.**
